

Cheerleading tryouts are Friday, April 5, 2019!

Step One: Read this packet in its entirety.

Step Two: Parent and candidate must sign all forms included in this packet. (See the Cheerleader Checklist to ensure that you have all documents.)

Step Three: Return all forms to Cecille Alexander in Room 308 by Monday, April 1, 2019. If you attend another school, please put the application in a sealed envelope addressed to "Cecille Alexander" and ask your AP or the cheer coach at your campus to send it to South Garland. Please bring your \$10.00 clinic fee with you on Monday, April 1, 2019.

Dear Parents,

This is just a note to introduce us and to acquaint you with the expectations of a South Garland cheerleader. We hope that you, as parents of a prospective cheerleader, are aware of the time and energy it takes to be an effective student leader responsible for guiding student conduct at extra-curricular activities and during the school day.

All South Garland cheerleaders will be expected to abide by the standards and guidelines outlined in the Garland ISD Cheerleader Handbook. If you are interested in viewing the Cheerleader Handbook prior to tryouts, please visit the following website: http://www.garlandisd.net/content/spirit-groups. All cheerleaders will receive a copy after squads have been formed. Cheerleaders who fail to adhere to the standards and guidelines will be penalized.

Candidates selected to be a member of the cheerleading squad are expected to make a commitment to the activity for the full cheerleading year or until their graduation date, depending on which comes first. SGHS Cheerleaders must give 100%, and complete their commitments and responsibilities to SGHS cheerleading before anything else. SGHS Cheerleaders will have additional duties, which they will be required to perform throughout the year. These duties will include (but are not limited to): cheerleading camp, parades (Labor Day, MLK day etc.), preparation for homecoming festivities, for games indicated in the cheerleading constitution, attendance at athletic play-off games, and participation in various school and community service projects. A great amount of time and energy will also be asked of the parents/guardians in providing transportation to some of the activities and in other miscellaneous functions during the year.

The <u>estimated</u> cost of cheerleading for <u>one year</u> is outlined below. The greater part of these expenses is incurred during the first three months after tryouts. Every effort has been made to keep these costs to a minimum. The stated costs include fees for camp instruction/week, camp wear, season wear, and accessories. Late fees will be assessed for all payments past due. The costs may vary depending on the size of each squad.

Following tryouts, new cheerleaders will be given a list of spring and summer obligations for SGHS cheerleaders. It is very important that all newly selected cheerleaders attend the practices and functions listed. The absence of any member affects the productivity of the entire squad. Consequences for missing these activities are also detailed in the GISD Cheerleader Handbook. All SGHS cheerleaders may participate in other sports or activities. The cheerleader must work out the conflicts with both coaches/sponsors to ensure only minimal disruptions in practice or games.

We hope that you will discuss the expectations and obligations of being a South Garland cheerleader with your son/daughter, and agree that South Garland Cheerleading is a worthwhile organization. Cheerleading helps students to form friendships, enrich communication, and develop group dynamic skills. It also gives them countless opportunities to foster leadership skills that will prove beneficial later in life. With your support we can work together to make this year the most successful ever for our program. We look forward to meeting each of you during the coming year. ELIGIBILTY FOR 2019 CHEER TRYOUTS

- If a student fails a class on the UIL eligibility list during the 4th grading period, he/she becomes ineligible at the end of the school day on February 22 and will regain eligibility on March 22 if <u>all</u> classes are passed on the 5th progress report. If the student is not passing all classes at that time, then he/she will only be eligible for the one-day tryout event.
- Students can participate in the one-day tryout regardless of eligibility. Ineligible students may NOT participate in the clinic in any fashion. They may not even watch.
- If a candidate is academically ineligible or does not attend the clinic for any reason, it is the responsibility of that candidate to arrange with the sponsor to receive a tryout number.

DRESS CODE FOR TRYOUTS

All candidates must wear a plain white polo styled shirt (no visible logo), black knit shorts, white socks, and white athletic shoes. Hair must be up in a secure high ponytail out of the candidate's face. To insure uniformity, no hair bows, ribbons, or any other accessories/jewelry will be allowed.

PANEL TRYOUTS

Friday, April 5, 2019:

3:15 - 4:00 p.m.: Warm up in Small Gym- VARSITY and JV candidates

5:00 – 5:30 p.m.: Freshman Candidates

We will provide you with the number that you will wear for tryouts. You are not allowed to switch numbers with another candidate.

Varsity Tryouts will begin at 3:45 p.m. in the Main Gym. JV will follow when Varsity is complete in the Main Gym. Freshmen will begin at 5:15 p.m. in the Main Gym

These tryouts are closed to the public. No parents or friends will be allowed in the building at any time during tryouts. No exceptions! Candidates, do not leave until you are dismissed. Same rules will apply to Mock tryouts.

Tryouts will be videoed on a district-maintained iPad. They will be controlled and turned into the judges by an Assistant Principal. **The coaches will never have access to the tryout videos.** Parents/students will not be able to see these videos due to FERPA laws. If you have any questions about the new process, please contact a sponsor or the Visual and Performing Arts department of Garland ISD.

Every attempt is made to hire judges that have not worked with students in the Garland area. However, with the hundreds of camps in the state of Texas, attended by thousands of cheerleaders and taught by hundreds of instructors, it may be possible at some time that a member of the judging panel may have had some contact with a candidate who is trying out. Professional judges with outstanding credentials and references will be hired for all tryouts. They will be instructed to judge the candidates based only on the mastery of the skills that they see demonstrated during the tryouts. Tryout results will not be challenged because of prior knowledge of judges and candidates.

TABULATION OF SCORES

Each judge will enter his/her scores into a scoring spreadsheet. The tabulation spreadsheet will automatically throw out the scores of the lowest and highest scoring judges. Results will be based on the average of the remaining three scores. A person not connected to the tryout will use a computer-generated formula to calculate scores district wide. Each candidate must score a minimum percentage of points in order to be placed on a cheerleading squad.

HS Freshman – 40%

HS Junior Varsity – 45%

HS Varsity – 50%

NOTIFICATION

Final results for each school will be published on the GISD Internet Website by 7:00 p.m. on Sunday, April 7, 2019. Candidates will be given an envelope with the website address at the conclusion of the tryouts.

REQUEST FOR SCORES

If you would like a copy of your individual scores mailed to you, please bring a stamped, self-addressed envelope to the sponsor *prior* to the tryouts. **Due at Mock Tryouts.**

TRYOUT SEQUENCE OF EVENTS

FULL GROUP PERFORMANCE:

ALL candidates should walk in and perform chant, dance, cheer as a group in that order. It should be explained that this is only so the judges can see what the material should look like and that they will not be judged at that time.

GROUP CHANT:

Groups should consist of 2 or 3 candidates. They should enter the gym so that that they end up standing in numeric order from left to right. (From the judge's viewpoint) There should be no tumbling or spirit during this time, only uniform walking. Once the nod has been given, the designated candidate should call for the group chant to begin. Upon completion, the candidates should wait for the judges to finish scoring.

GROUP DANCE:

Once the nod has been given, the school representative should start the music for the dance. Once this has been completed, the candidates should remain in their spots until they are told to leave. This will enable the judges to correspond the scores with the candidate numbers.

INDIVIDUAL ENTRANCE:

Candidate number #1 should enter the gym and wait for notification from the videographer that they are ready. After the judges have nodded, the candidate should run in showing and soliciting spirit and enthusiasm doing whatever tumbling pass they wish if they are able. Once they are done with their entrance, they should stop in the center of the gym and wait for notification that the judges are ready for the next step.

At this point, the judges will score the tumbling, spirit/enthusiasm, and the candidate's presence/poise. Presence/poise will include appearance with regard to the hair being out of the face, shirts tucked in if possible, shorts not being too short, proper shoes, facial expressions, etc.

INDIVIDUAL JUMPS:

Once the nod has been given, the candidate should do whatever jump they wish to do first and then wait for a nod before doing their second jump and then their third jump, giving the judges time to score each jump. Each high school candidate must perform a toe touch, a right hurdler (Facing Forward), a left hurdler (Facing Forward), and a jump of his or her choice. The jump of their choice can include, but is not limited to, a jump that they have already performed.

INDIVIDUAL CHEER:

Once the jumps have been completed and the nod has been given, the candidate should begin their cheer. The cheer will have a section(s) incorporating a jump(s) and/or tumbling. Candidates will be scored based on difficulty and execution. Candidates will also be judged on their smile, motion technique and voice projection during this time. Once the candidate has completed their cheer, they should exit the gym. No score will be given for an exit tumbling pass or spirit.

High School Cheerleader Squad Rules and Deduction System

The following is the basic standard for a cheerleading squad decoction system. Each campus will create individual squad rules that lay out guidelines and consequences for infractions. Individual squad rules may expand upon the district deduction system in order to address campus specific priorities but will not exclude any district standard. Campus cheer rules and guidelines will be in line with the GISD Student Code of Conduct and all UIL quidelines.

The conduct guidelines for each High School cheer squad will be approved by each campus principal and the district VAPA department. Each cheerleader and parent will agree to the team rules and be required to sign a statement attesting to their agreement. The rules and procedures are in effect from the time the student is selected to the cheerleading squad until the next tryout date.

- After a 15-point deduction, the cheerleader will be benched for one game or event. If he/she accumulates 25 points in different offenses, he/she will be benched for the remainder of the six weeks. After the individual is benched one game for accumulating 15 points, the points will continue to be deducted from the six weeks grade; to accumulate toward the 25 point total, and/or possible failure
- Accumulation of three or more benchings will result in a principal/sponsor review, which could result in removal from the squad.
- 3. Injuries: If an injury occurs that keeps the student out of two practices, a doctor's note will be required. This note should state the length of time of the restriction, the specific task the student cannot perform, and any special instructions. Lack of participation will be categorized as missing practice if there is no note.
- Repeated/excessive offenses will result in a sponsor/principal review. Repeated/excessive is defined as repetition of the same offense three or more times during the duration of a season.

Seasons are:

Football – beginning of school until December 1 or the last football game, whichever is later.

Basketball – December 2 until March 1 or the last basketball game, whichever is later.

Violation of the same rule or guideline three or more times in a season will result in the CL being placed on probation for the remainder of that season.

Violation of the probation by further misconduct could result in dismissal from the squad.

Any sponsor and principal review of student's actions may result in dismissal from the squad.
