

## **North Garland High School Parent Involvement Policy**

- ❖ Volunteers are recruited to serve on the Campus Improvement Committee (CIC) and Parent Advisory Committee (PAC)
- ❖ The CIC will be responsible for the joint development of the school wide plan and the PAC will be responsible for the joint development of the Parental Involvement Policy.
- ❖ The CIC will meet 5 times during the school year to address campus needs as they relate to the school wide plan and the Parental Involvement Policy.
- ❖ The PAC will meet 3 times during the school year to address campus needs as they relate to the school wide plan and the Parental Involvement Policy.
- ❖ Parents will be given the opportunity to comment on the school wide plan and Parental Involvement Policy when they are made public to the community
- ❖ An annual review, evaluation, and revision of the Parental Involvement Policy and school wide plan will occur in the spring semester and will include parents through surveys and focus group as well as the CIC.
